 - The school held the Annual Title 1 Meeting on Thursday, September 28, 2023 and on Tuesday, October 24, 2023. The principal displayed and discussed the PowerPoint presentation and obtained parent signatures.

Meetings are scheduled in the evenings via zoom link. The evening meetings are more suitable for our parents due to their work schedules. There are daytime meetings offered as well.

 - Notices of meetings are sent to the parents from our communication Dojo board, school messenger recordings, and emails.

The lines of communication and collaboration are kept open among the ESL team, principal, and the parents. There are four ESL students at our school and the parents are proficient in English. ELL parents will receive information in a language they can understand. These students will be identified during registration.

The lines of communication to our parents have been made available through emails, zoom meetings, parent conferences, and telephone calls. The standards of learning/curriculum are discussed through Schoology, the grade level school newsletters, weekly homework sheets, interactive notebooks, and students' progress is discussed weekly through the gradebook/porta portal accounts/Dojo communication board. Parents of ELL students will receive additional resources from the ELL program. They will be provided information in a language of their understanding.

- G. If school wide program plan is not satisfactory to the parents of participating children, submit any parent comments on the plan when the school makes the plan available to the district.
 - The plan has been discussed with the parents and no feedback forms were returned indicating any necessary changes. A School Parent Advisory Committee is established yearly with 1-2 parents representing each grade level and meeting 3-4 times a school year. During the meeting sessions, topics of discussions are school climate, improvement plan review, and other school related subjects dealing with student achievement.

Parent surveys will be sent out at the conclusion of every parent event. The surveys will be used to address concerns and drive our parent engagement program.

To ensure effective involvement of parents and to support a partnership among the school involved, parents, and the community to improve student academic achievement, each school and district must:

 - The Student Detail by Question Reports along with an explanation of the reports were mailed to the parents. The teachers answered any questions that the parents had pertaining to their child's performance on the Standards of Learning Tests given in May 2023. SOL Workshops for Reading, Math, and Science were hosted for our parents and testing strategies were shared for increasing student achievement.
- Provide materials and training to help parents to work with their children, such as literacy training and using technology (including education about the harms of copyright piracy).
 - The math specialist, reading specialist, and the PALS coordinator conducted the following parent workshops: September 19, 2023- "Let's Talk Kindergarten- Understanding VKRP & PALS (Literacy)"; "Title 1 Network for Learning". There were two sessions: in-person and a zoom link was provided for the parents who could not come into the building. The Technology Resource Teacher created the following videos on Class Dojo: "Parenting in a Digital Age" and "Family Tips: Cyberbullying, Digital Drama and Hate Speech".
- Provide professional development to teachers, specialized instructional personnel, and other staff on the value of parent and their communities to increase academic achievement.
 - The Parent and Family Liaison will host a parent workshop for the teachers and share strategies that will foster positive relationships for increasing student achievement.

Coordinate and integrate parent engagement programs and activities with other Federal, State, and local programs, including public preschool programs, and conduct other activities, such as parent resource centers, that encourage and support parent engagement.

Parents have access to the parent resource center at Churchland Primary and Intermediate School. The parents attended a workshop titled "Understanding VKRP & PALS (Literacy)". The Preschool tour takes place in the spring and the rising kindergarten students tour Churchland Primary and Intermediate. The students tour the school and at the end of the tour they ask questions.

Flyers pertaining to parent workshops and school activities are posted on the school website, the Dojo board, and the school messenger recordings are scheduled. Student saddlebag folders go home weekly with important school updates.

The trainings for the parents were based on a survey created by the Parent and Family Engagement Liaison. The parents attended staff development workshops with the teachers and the principal on "Effective Reading Strategies", "Understanding Special Education", "Understanding the Standards of Learning", and "Making Math Connections."
- 2) May provide necessary literacy training from funds received under this part if the district has exhausted all other reasonably available sources of funding for such training. The district provides monthly Learning Community Workshops on Literacy. The Reading department provides weekly support to the teachers on the Science of Reading. The Reading Specialist will conduct a parent workshop for increasing vocabulary, fluency, and comprehension.
- 3) May pay reasonable and necessary expenses associated with local Parent and Family Engagement activities, including transportation and childcare costs, to enable parents to participate in school-related meetings and training sessions. Title 1: A- funds were utilized for the parent event "Grand-Relatives Matter-Bonding with Books", "Understanding VKRP & PALS" and "Magnifying Our Solar System". The funds were utilized to support the students who engaged in hands-on activities while the parents participated in staff development workshops.
